ADOPTION AGREEMENT

The Biewer Breed Club of America Rescue (hereinafter referred to as the Biewer Rescue or BBCAR) is a non-profit organization recognized as a Chapter of the Biewer Breed Club of America Inc., and is dedicated to the betterment and welfare of the Biewer a la Pom Pon.

The Board of Directors of the Biewer Breed Club of America Inc., has selected a Rescue Committee chairperson to preside over the Biewer Rescue organization. The Chairperson acts on behalf of the BBCAR at all times, and as such is responsible for the suitable placement of Biewer Rescue pets. A Biewer is not to be acquired casually, or disposed of lightly.

TERMS OF ADOPTION AGREEMENT

I, _____, do hereby understand and agree to the terms of the adoption for a male/female Biewer, aged _____, with the call name of _____, identified as No: _____ in the BBCAR register. Further, I understand and agree that if at any time, for any reason whatsoever, I can no longer keep this dog it will be immediately returned to BBKA Biewer Rescue.

I want to make a donation to the Biewer Rescue fund of _____ to cover veterinarian and rescue expenses. I also understand that the Biewer I adopt will be spayed or neutered prior to adoption or I guarantee that it will be spayed or neutered within sixty (60) days. A veterinarian will examine the dog, and vaccinations updated if not current. Tests to determine if the dog has any internal or external parasites will be performed. Corrective action (if any) will take place as determined by joint agreement between the veterinarian and the Chairperson and Committee Members of Biewer Rescue on behalf of the Biewer Breed Club of America.

I have been given an information brochure detailing the care and needs of the Biewer, and agree to adhere to the requirements as detailed. Two home visitations may take place (one announced and one unannounced) to ensure the placement is to the benefit of both the dog and the adoptive owner. The ownership and responsibility for the adopted Biewer belongs solely to the adoptive owner. However, if at any time it appears the dog is not being cared for appropriately, or humanely, or is being ill-treated, the Biewer Breed Club of America Inc., and the Biewer Rescue retains the right to remove the dog from the adoptive home and take the dog back into rescue. It is fully understood by both parties that any breed Registration will be withheld, and no sire/dam information will be furnished. The breeder's name and former owner's name will also be withheld.

Further, the Biewer Breed Club of America Inc., the Board of Directors, and the Biewer Rescue shall be held harmless for any bodily injury or property damage caused by any adopted Biewer or by the actions of its adoptive owner. I, adoptive owner, hereby specifically assume responsibility for any and all loss and expenses (including legal fees) incurred by reason of liability imposed by law upon the BBCA Inc., the Board of Directors, and BBCAR because of bodily injury to any person or persons including myself (the adoptive owner) or any damage to property arising out of its consequence of the placement of the Biewer, howsoever such injury, or damage to property may be caused, or may be alleged to have been caused, by negligence of the aforementioned parties or any of the employees, agents, or members, or any other person.

I (we) represent that I (we) have never been subject to legal action for cruelty to, or neglect of, animals. I (we) represent that I (we) have never owned an animal that has been confiscated by any animal control or humane organization for violations of animal control regulations or animal adoption agreements.

If at any time I should change my address, I understand that I must notify BBCA Biewer Rescue of my new address.
